Master Apprentice | Students who have completed their apprenticeship and pending to take the AAM Exam

If you have completed all 15 case studies, but have not yet taken and/or successfully passed the AAM Board Exam, you may schedule clients for procedures (minimum rate of \$395 per procedure), and work as a "Master Apprentice" under the supervision of one of our board certified practitioners.

Independent Contractor | Students who completed the apprenticeship & took their AAM Exam

Once you have successfully passed your AAM Board Exam, you are now able to work legally in the State of New Jersey. Prior to beginning work as an independent contractor, you will be required to complete general paperwork (Independent Contractor contract, W9) and obtain General Liability Insurance with the company listed as an additional insured.

Payments/Gratuities will be applied to any outstanding balance.

If the minimum rate for initial appointment is equal to or greater than \$795, 2nd visit (touch-up) can be provided free of cost (\$0). \$295 touch-up fee for 3rd and subsequent appointments.
